### **Old Business:**

## 1. Grading Scale

- a. Elementary 90-100 A already happens within the new Sapphire program
- b. New grading scale would match up better with college courses
- c. Other local districts have this same grading scale that is being proposed
- d. 90-94.99% Honors, 95+ High Honors, 65 and lower passing
- e. 90+ A, 80-89 B, 70-79 C, 65-69 D, 64 and lower Failing
- f. We currently have standards higher than PIAA
- g. Discussed implementing a warning week for athletic policy suggestion
- h. New model would provide more opportunities to students at the failing level to bring their grades up. It also would provide more opportunities for students who are succeeding to get the credit they deserve.
