The following is a summary of the 13 March 2023 school board work session, which began at 7:05 p.m.

- Charles Fritz from the Town of Bloomensburg presented information on a grant for which the town is applying to make repairs to the tennis courts. Mr. Fritz requested a letter of support from the board for the grant application.
